Quarterly Update Summary

In Q1, the Vegetation Management program has been working in the Boulder Bay area and moving west towards the village. (See Grids I-7, and J-7). The pre-inspector also found numerous cycle busters in grids(I-14 and J-15). All cycle breakers found to be in violation were trimmed. Routine work has been significantly slowed due to the large amount of snow making access to areas difficult.

Vegetation crews are still working on the large list of removals. A number of trees are being cited by the fire department and have been deemed a threat to our lines. Crews will prioritize the highest risk tree to remove first.

BVES also brought on our new forester Brenda Steinert, who is contracted through DRG. In Q2, Brenda will be working on re-inspecting all the major woody stems for the June 30 due date set by Calfire.
